Term: The Governing Body shall be reconstituted every five years.

Meetings: Meetings of the Governing Body shall be held at least once every six months.

Quorum: Presence of a minimum 50% of Members will be the quorum.

Functions of the Governing Body:

Subject to the existing provision in the bye-laws of the respective Autonomous College and rules laid down by the State Government/Parent University, the Governing Body shall:

- a) Guide the Autonomous College while fulfilling the objectives for which the College has been granted autonomous status.
- b) Institute scholarships, studentships, fellowships, prizes, and medals, and certificates on the recommendations of the Academic Council.
- c) Approve new programmes of study leading to degree and/or diplomas.
- d) All recruitments of Teaching Faculty/Director shall be made by the Governing Body/state government as applicable in accordance with the policies laid down by the UGC and State Government from time to time.
- e) To approve the annual budget of the Autonomous College.
- f) Perform such other functions and institute committees may be necessary and deemed fit for the proper development of the Autonomous College.

NOTE: The Parent Society (ITES) has a right to remove or add any member in the Governing Body of the institute.
